**CAMO PROVIDED SEVERAL CAPITAL IMPROVEMENTS INCLUDING REMODEL OF HOSPITAL KITCHEN, REPAIR OF VARIOUS AREAS OF HOSPITAL ROOF, CONTINUED SUPPORT AND MAINTENANCE OF COMMUNITY DAY CARE CENTER AND COMMUNITY GYM. THE WOMEN'S SHELTER IS CAPABLE OF HOUSING 44 PEOPLE (BY USA STANDARDS), AND OVER 100 INDIVIDUALS (BY DEVELOPING COUNTRY STANDARDS) AT ONE TIME.
