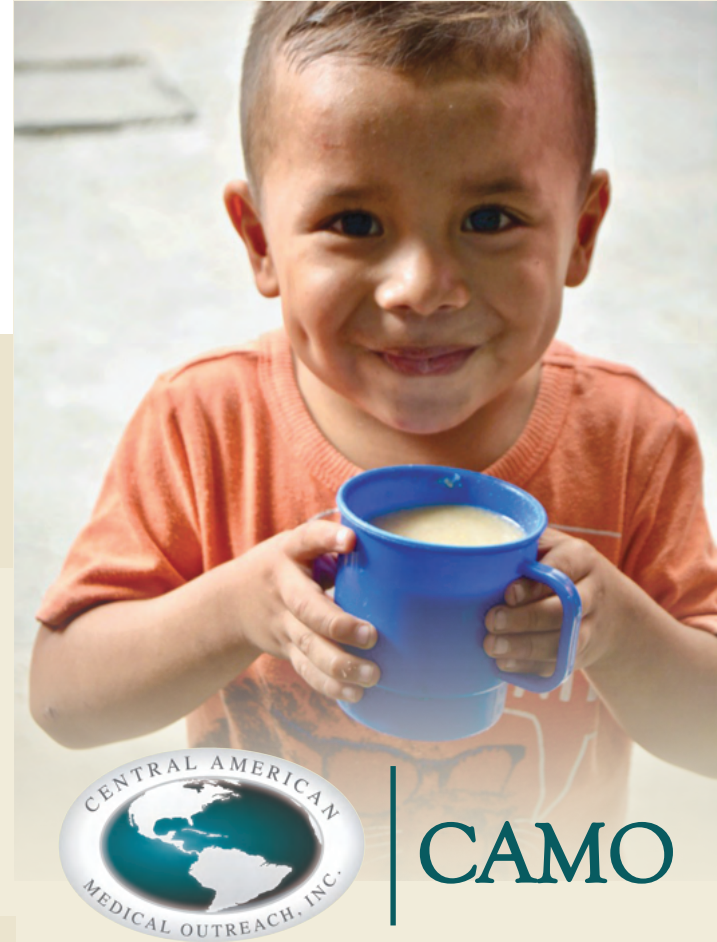

BEQUESTS

By making a provision in your will or trust you can support CAMO in the future through a bequest this could be a specific amount, a percentage or all the rest and residue. Bequests offer flexibility and can be structured to fit your personal situation.

BENEFICIARY DESIGNATIONS

An alternative to a bequest gift is to designate CAMO as the beneficiary of your retirement plan assets. This gift is simple and you can name CAMO as the beneficiary without changing your will or trust. A gift of retirement plan assets has the added advantage of being among the most tax-wise ways to make an estate gift. You can also name CAMO as a beneficiary of your insurance policies and other financial accounts.
